ORDINANCE No. 188258

*Extend contract with StellarRAD Systems LLC, through June 30, 2018, and increase the contract value by \$247,960 for a contractual not to exceed amount of \$1,372,960 for maintenance of the Communications Network (Ordinance; amend Contract No. 41090)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Contract No. 41090 was entered into with StellarRAD Systems LLC (Contractor), a Delaware limited liability company in 2007, to provide an operational system to support the administrative, operational, financial, maintenance, and regulatory reporting requirements of the Integrated Regional Network Enterprise (IRNE) for the City.
- 2. This Ordinance authorizes the extension of the Contract through June 30th, 2018 to allow BTS to complete the negotiation and implementation of a new contract resulting from a competitive solicitation.
- 3. This Ordinance increases the not to exceed value by \$247,960 for a new total not to exceed value of \$1,372,960. This contract has been amended three (3) previous times to extend and add compensation, but the per year charges have remained the same throughout the term. This increase is the same per year charge but adds some additional maintenance services.
- 4. On-going funding for this contract extension will be provided by the Bureau of Technology Services.

NOW, THEREFORE, the Council Directs:

a. The Chief Procurement Officer is authorized to amend Contract No. 41090 with StellarRAD Systems LLC to extend the term through June 30th, 2018 and increase the not to exceed value by \$247,960, provided such amendment has been approved as to form by the City Attorney.

Section 2. The Council finds that an emergency exists in order to avoid a lapse in providing support services for the Communications Network; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.


