ORDINANCE No. 188268

Extend term of a franchise granted to NewPath Networks, LLC to build and operate wireless facilities within City streets (Ordinance; amend Ordinance No. 180376)

The City of Portland ordains:

Section 1. The Council finds:

- 1. In August 2006, the City Council granted a franchise to NewPath Networks, LLC, to build and operate wireless facilities within the City's streets. Ordinance No. 180376.
- 2. The Council has extended the term of the franchise three times. Ordinance No. 184797; Ordinance No. 185775; and Ordinance No. 186949.
- 3. City staff continues to work with telecommunications industry representatives in an effort to standardize and modernize the terms and conditions of all franchises.
- 4. City staff recommends that the Council extend the existing franchise to allow time for the parties to complete negotiations and to formally conclude the Portland City Charter procedure for franchises, which can take up to four months or more from the date of required initial publication.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 180376 is hereby amended to extend the term of the franchise, continuously and without interruption, to August 31, 2018.
- b. All other terms and conditions of the franchise shall remain the same and unchanged.

c. On or before the thirtieth (30th) day after this ordinance becomes effective, NewPath Networks, LLC shall file in the Office of the Auditor of the City of Portland a written acceptance of this ordinance, executed by NewPath Networks, LLC meeting the approval of the City Attorney. Any failure on the part of NewPath Networks, LLC to file such written acceptance within such time shall be deemed an abandonment and rejection of this ordinance, and shall be construed to be an acceptance of all the terms contained in this ordinance.


