

ORDINANCE No. 188271

Authorize a contract with lowest responsible bidder for the construction of the Wheeler Basin Reconstruction and Green Streets. Project No. E10219 for \$7,033,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) has identified in their 2012 Systems Plan a need to replace undersized sewers in the Wheeler Basin. Eight Vegetated Green Street Facilities will reduce the need to replace some of these sewers. Approximately 9,344 linear feet of combined sewer pipe will be replaced by this project with pipe with adequate capacity (8-30 inches in diameter), and 2,100 linear feet of new sanitary or storm sewer pipe will be installed (8-24 inches in diameter). Also approximately 6,500 linear feet of six-inch sewer service laterals will be replaced from the sewer to curb with this project.
2. The Bureau of Environmental Services along with Century West Engineering and Emerio Design LLC has prepared plans and specifications for the Wheeler Basin Reconstruction and Green Street Project. The Bureau of Environmental Services requires the furnishing of materials and labor for this project.
3. The estimated cost is \$7,033,000. The level of confidence is high. Funds are available in the Sewer System Operating Fund, FY 2018-FY2019 CIP, Bureau of Environmental Services WBS Element E10219.C60.

NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office
- b. The Mayor and City Auditor are hereby authorized to pay for the contract from the Sewer System Operating Fund Budget.




