## TO THE COUNCIL:

On November 17, 2016, Council approved Ordinance Number 188100 for Procurement Services to competitively solicit the Colonel Summers Park Splash Pad and Portland Loo Installation Project in accordance with PCC 5.34. The Chief Procurement Officer has advertised and received bids for Bid Number 00000499 on behalf of Portland Parks and Recreation (PP&R), with a project construction estimate of \$576,242.00. PP&R rated the project estimate confidence level as Medium.

Bids were opened on February 9, 2017, and three (3) bids were received. The low bid from T Edge Construction, Inc. was responsive to the solicitation requirements, thus it is recommended that T Edge Construction's bid be accepted at the unit prices quoted for a total bid amount of \$673,530.00 which is 14.5% over the Engineers Estimate.

PP&R along with Procurement Services, identified an aspirational goal for D/M/W/ESB subcontractor and supplier utilization at 20% of the hard construction costs for the project.

The types of work identified by T Edge Construction, Inc. as being performed by subcontractors/suppliers for this project are:

In their bid, T Edge Construction, Inc. indicated their intent to self-perform the following types of work:

There is a total of \$673,530.00 (100%) D/M/W/ESB participation on this project including the prime contractor at 77.6% and certified subcontractors at 22.4% apportioned as follows:

- DBE \$20,850.00 performing sewer work and surveying.
- WBE \$114,179.25 performing mechanical and landscaping
- ESB \$14,750.00 performing electrical.

T Edge Construction, Inc. is located in Happy Valley, OR, and is a State Certified DBE/WBE/ESB Contractor. They have a current City of Portland Business Tax

Registration and EEO Certification, and are in Full Compliance with the Equal Benefits Program.

Funds are available for this project under Owner Cost Center P30103.

It is recommended that a Performance Bond and Payment Bond each at 100% of the contract amount be furnished by the Contractor. Further, it is also recommended that a two (2) year Maintenance/Warranty Bond for 20% of the final contract amount be furnished by the Contractor before final payment is released.

The bid sureties of the remaining bidders should be returned immediately in compliance with Section 5.34.410D of the City Code.
