Authorize a contract with the lowest responsive bidder for construction of the SW 45th Avenue and Fanno Creek Culvert Replacement Project No. E08676 for an estimated cost of \$735,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Environmental Services (BES) needs to replace an undersized culvert crossing under SW 45th Avenue to reduce the risk of flooding and provide fish passage.
- 2. The replacement of the culvert crossing will reduce the risk of flooding, enhance fish passage, and provide stream restoration in this reach of Fanno Creek.
- 3. The estimated cost is \$735,000. The level of confidence is high. Funds are available in the Sewer System Operating Fund, FY2017-FY2021, CIP, Bureau of Environmental Services, WBS Element, E08676.C60.

NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office
- b. The Mayor and City Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget.
