

Optimism. Confidence. And Belief

I am here on behalf of the general public of Portland. I gave testimony, in these chambers, last week about the lack of public awareness around the Centennial Mills development and this week I'd like to point out an example of a recently approved building that had virtually no public awareness. This development is in the NW 13th Ave. Historic District.

It's an office building, nearly twice as tall as the adjacent historic buildings and as such not compatible with adjacent building heights in the district. Not only has this project been approved, it is due to begin construction by the end of 2017. The proposed building is on the NE corner of NW Glisan and NW 13th Ave. The location is currently a street level parking lot.

The NW 13th Avenue Historic District Design Guidelines dated February 1996 state --To preserve the integrity and character of this special neighborhood, the guidelines stress that new development vertical heights are to be compatible with adjacent contributing historic buildings. Note: All 21 buildings in this historic district are contributing (Refer to graph poster)

The people of Portland deserve to have a greater voice in the approval process of this building, which is in the historical heart and backbone of the Pearl District. Allowing a building at this height will set a bad precedent for maintaining the historical character of this vital and universally acclaimed district.

Ted Wheeler Quote: *I think it is a huge mistake that you cannot reverse if you take a historic neighborhood or an historic business district that has unique architecture and you take that unique architecture away... then you are robbing the community of its uniqueness.*

As a concerned citizen, and knowing that most people are unaware of the approval process, I raised awareness within the community and created a petition. In less than a day's time I got over 100 signatures supporting the position that the proposed building is too tall for the historic district. (Refer to signed petitions)

I presented my research and findings to the Landmarks Commission who thanked me for my efforts but said that it was too late. They further said if I'd brought the information to them sooner, they very well could have ruled that the building was not compatible in height with the rest of the District.

That was very frustrating, since I had attended every public hearing and presented my information on as timely a basis as the process allowed.

The architects, builders, and developers were all heavily involved in this process-- everyone but the public.


The good news is the 14 day right to appeal period is still open; expiring this Friday March 31st. The bad news is it costs \$5,000. I am just not in a financial position to take one for the entire Portland general public 'team'.

This is where the people of Portland need your help and more importantly need your leadership. I am asking, on behalf of the citizens of Portland that you waive the \$5,000 appeal fee and allow the public to have a voice in this important decision.

I'm not asking that you agree with my assessment of the situation, I am merely asking for an opportunity for the public to be involved in this process on the front end rather than being discouraged when they find out after the fact.

Adopted by the Portland City Council February 21, 1996





NW13th Ave Historic District Design Guidelines

(Relevant excerpts regarding approval criteria for height and visual compatibility)

- One of the essential elements which defines the character of the NW 13th Ave Historic District is the high degree of compatibility among its visual elements and architectural relationships
- Contemporary design for new buildings and additions to existing buildings is not discouraged if such design is compatible with the size, scale, color, material, and character of the district, buildings or its environment
- The added height is visually compatible with adjacent historic buildings
