#### AMENDMENT NO. 1 Intergovernmental Agreement No. 30005339 City of Gresham Agreement No. 6865

Intergovernmental Agreement No. 30005339 between the City of Gresham and the City of Portland through the Portland Housing Bureau as a recipient of HOME Investment Partnership Funding through the Portland HOME Consortium is amended as follows:

#### Part 4. A. Grant Award to Gresham

The Intergovernmental Agreement is hereby amended to increase program resources by \$8,000 of earned program income, making the total grant award to the City of Gresham \$936,067.

- A. The amount of the grant award to Gresham under this IGA shall not exceed NINE HUNDRED THIRTY-SIX THOUSAND SIXTY-SEVEN DOLLARS AND ZERO CENTS (\$936,067) in HOME funds. The grant award requirements are contained in Section 11. Final invoice is due July 6, 2017.
- B. There is a total of \$936,067 in HOME funds available to Gresham in the City of Portland Housing Bureau Budget, comprised of \$470,090 in FY 2016-17 Gresham HOME funds, \$374,077 in carryover funds and Program Income of \$91,900. The City of Gresham will implement a portion of the HOME Program in the amount of \$891,538 in accordance with the Budget (Exhibit A). The balance of Gresham's HOME Program funding is \$44,529 and will be administered by the City of Portland. The allocation of funds to be administered by the City of Portland is detailed in the Budget (Amended Exhibit A).

Part 9. Scope of Services to be carried out by the City of Gresham.

- G. Set Aside Project for Homelessness (\$55,976)
- I. Scope of Services to be carried out by City of Portland
  - B. Portland HOME Consortium Administration (\$21,154)
