Thank you for the update, Dr. Smith. As you may have heard, Council meetings have been disrupted by protesters for several months. While we are trying a new approach, I'm hesitant to schedule a GPSEN update not knowing whether guests will be allowed to speak, or how delayed the meeting may become.

Possibly the best thing to do would be for you (and colleagues) to sign up for three-minute Citizen Communications spots. Send a written request to Karla with your name, address, and a brief title for your comments. I realize three minutes is not much time, but if there are several people willing to sign up from your team, you can string together the information from one person to the next.

While sometimes protesters start yelling right away, often they wait until later in the meeting - so presenting under Citizen Communications is probably your best option. Alternatively, you could wait until later in the year, when it's possible meetings may become more predictable again.

If you recall, the <u>Greater Portland Sustainability Education Network</u> (GPSEN) presented to the City Council in February, 2015. You asked that we come back each year and give an annual report. Two years later, I hope that you will still extend your invitation and welcome us to provide an update on local, regional, national, and international efforts.

With our continued recognition as a Regional Center of Expertise (RCE) on Education for Sustainable Development (ESD), by United Nations University and UNESCO, thanks in great part to the City of Portland's efforts and the many good people and organizations in our region, we have much to share. We have grown significantly and have accomplished a great deal since our last presentation (annual report attached), with GPSEN now recognized as one of the leading RCEs in the world (154 RCEs in the world; 5 in the U.S.).

If we may present at a City Council meeting, we would love to provide information on our efforts to support collaboration across sectors and seek your advice on how we can better support Portland's sustainability mission, including:

- Updates on our current programs in greater Portland
