ORDINANCE No. 188404

*Authorize a Temporary Site Access Agreement with Portland Public Schools, as part of the NE 82nd Ave, NE Davis St to NE Everett St Project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The general characteristics of this Safe Routes to School project was identified in PBOT's 2006 Engineering Review for Vestal Elementary school. Through relocation of the sidewalk, the project will improve pedestrian safety on NE 82nd Avenue in front of the school by creating a four foot buffer and standard full height concrete curb between pedestrians and moving vehicles. The project elements include approximately 240 linear feet of six foot wide sidewalk with concrete curb and the replacement of the SW corner ramp at the intersection of NE Everett Street and NE 82nd Avenue to meet ADA compliance. Four new trees will be planted in the buffer zone/planting strip.
- 2. Subject to indemnification by the City, Portland Public Schools has agreed to convey, at no charge, the necessary Temporary Site Access Agreement.

NOW, THEREFORE, the Council directs:

a. The PBOT Director is hereby authorized to execute a Temporary Site Access Agreement with Portland Public Schools in substantially the same form as the agreement attached as Exhibit A.

Section 2. The Council declares that an emergency exists because delay in property acquisition may result in a delay in construction and impact the overall project completion; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
