* Amend loan agreement with Oregon Infrastructure Finance Authority for the Levee Ready Columbia effort to extend project completion deadline (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On May 28, 2014, the Council authorized the execution of a loan contract with the Business Oregon Infrastructure Finance Authority to assist in the financing of an engineering analysis for what was then known as the Columbia River Levee Project (the "Loan," Ordinance No. 186598).
- 2. It has become necessary to extend the project completion deadline and to amend the authorized scope of work eligible for payment from the Loan.
- 3. This modification to the Loan will not increase the cost of the City's obligations thereunder.

NOW, THEREFORE, the Council directs:

a. That the Debt Manager of the City, the Director of the Bureau of Revenue and Financial Services, the Chief Administrative Officer of the Office of Management and Finance, and the person designated by the Chief Administrative Officer of the Office of Management and Finance to act as Debt Manager under this ordinance are authorized to execute an amendment to the Loan in a form substantially similar to the draft amendment attached as Exhibit A.

Section 2. The Council declares that an emergency exists because a delay in approving the amendment would interfere with the scope of work needed to complete the engineering analysis and timelines established for receipt and repayment of the Loan; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
