## RESOLUTION No. 37296 As Amended

Support Smart Autonomous Vehicle Initiative implementation (Resolution)

WHEREAS, autonomous vehicles (AVs) represent a transformative technology that stands to reshape how people interact and use private and public transportation on our nation's streets and highways; and

WHEREAS, deployment of autonomous vehicles has the potential to increase the safety of all transportation users, increase mobility for everyone, including the disabled and the elderly, decrease congestion on our nation's surface streets and decrease climate pollutants produced by the transportation system; and

WHEREAS, Portland's Smart Autonomous Vehicle Initiative (SAVI) will set an autonomous vehicle policy, invite automated vehicle testing and pilots, outline local regulation and permitting of autonomous vehicle technology, and develop a public outreach strategy.

NOW, THEREFORE, BE IT RESOLVED, that the City of Portland is directed to include the draft Autonomous Vehicle Policy in the update of the Transportation System Plan 3 update, attached as Exhibit A; and

BE IT FURTHER RESOLVED, the City of Portland supports the intent of the Autonomous Vehicle Request for information, attached as Exhibit B, and directs the Bureau of Transportation to use the information received to launch autonomous vehicle pilots in line with Portland's policy goals; and

BE IT FURTHER RESOLVED, the Bureau of Transportation shall continue to regulate and permit the use of Autonomous Vehicles through administrative rules in coordination with state and regional partners; and

BE IT FURTHER RESOLVED, the Bureau of Transportation shall implement its proposed Outreach Strategy, as attached in Exhibit C.

BE IT FURTHER RESOLVED, that prior to issuing any permits for autonomous vehicle use or approving any pilot activities based on the Request for Information, the Portland Bureau of Transportation will bring a summary of the Request for Information responses and recommended actions to City Council.


