* Authorize contract with HDR Engineering, Inc. for the design of the North Rivergate Overcrossing project in the amount of \$2,222,941 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. North Rivergate Blvd provides a key access to several large employers in the Rivergate Industrial Area. The roadway is often blocked by freight trains and rail operations creating significant delays and potential safety issues.
- 2. The Port of Portland and the City of Portland have received funding from the Federal Highway Administration TIGER (Transportation Investment Generating Economic Recovery) program for construction of an overcrossing.
- The Port of Portland and the City of Portland will also contribute match to the project. In June 2015 Council Authorized \$5,000,000 in Transportation System Development Charge funds for the project.
- 4. In order to expedite design and construction of the project PBOT has agreed to use a portion of the Transportation System Development Charge Funds to fund the Preliminary Engineering phase of the project.
- The Bureau of Purchases and Bureau of Transportation issued a Request for Proposals for the design of the project. HDR Engineering was awarded the contract.
- 6. The Bureau's level of confidence in the cost estimates for this project is _high for the Preliminary Engineering Phase of the project.

NOW, THEREFORE, the Council directs:

a. That the Commissioner-in-Charge is hereby authorized to approve a contract substantially in accordance with the draft contract attached as Exhibit A, with HDR Engineering for design of the North Rivergate Overcrossing Project in an amount not to exceed \$2,222,941.00.

Section 2. The Council declares that an emergency exists because it is critical to begin design of this project to meet the timelines specified in the FHWA TIGER Grant. therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
