ORDINANCE No. 188469

Authorize the Intergovernmental Agreement for the crisis information management system WebEOC shared software among the City of Portland and the Oregon counties of Multnomah and Washington (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City, as the WebEOC License Holder, is responsible for system management, administration, and maintenance; and
- 2. The WebEOC license purchased by the City was intended for use by the City, Multnomah County, Washington County, and other agencies and organizations within those counties; and
- 3. WebEOC provides a platform to receive, process, and manage event and incident information and serves as a collaboration tool for information sharing and development of a common operating picture among public safety agencies and critical infrastructure operators; and
- 4. The City, as the License Holder, and the counties as Primary Users of the system desire to form a partnership to coordinate system management, administration, and maintenance; and
- 5. ORS 190.010 to 190.030 authorizes units of local government in the state of Oregon to enter into written agreements with any other unit or units of local government for the performance of any or all functions and activities that any of them has the authority to provide.

NOW THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to approve, by signature, the webEOC, crisis management system shared software by this IGA.
- b. The Director of the Portland Bureau of Emergency Management of the City of Portland is authorized to accept on behalf of the City of Portland any subsequent modifications to the IGA provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.
