ORDINANCE No. 188472

Amend grant agreements for navigator services at the Gateway Center for Domestic Violence Services for a combined annual amount of \$267,000 (Ordinance; amend Contracts Nos. 32000375; 32000391; 32000976; 32000977; and 32000998)

The City of Portland ordains:

Section 1. The Council finds:

- On October 21, 2009, the City Council, through Portland City Ordinance no. 183257, entered into an intergovernmental agreement with Multnomah County, Oregon (County) to jointly operate a One Stop Center for Domestic Violence (County Contract no.30000956). The Center is now known as the Gateway Center for Domestic Violence Services ("the Center").
- 2. A request for proposals for grant funding to provide "navigator" (advocacy) services was circulated amongst community-based domestic violence service providers on April 15, 2010.
- 3. Six non-profit corporations (The YWCA of Greater Portland ("YWCA"), the Immigrant and Refugee Community Organization ("IRCO"), Ecumenical Ministries Russian Oregon Social Services ("EMO"), Bradley Angle ("BA"), the Native American Youth Association (NAYA), and Catholic Charities El Programma Hispano "El Programma"), (collectively the "Grantees") sought grant funding to provide the navigator services at the Center. There were no other responses to the request for proposals.
- 4. One grantee, El Programma, agreed to administer a client assistance fund of \$20,000 annually for small needs that survivor participants may have for which no other fund is available. El Programma is willing to continue to administer this fund.
- 5. Portland City Council authorized grant agreements with the six Grantees after the Grantees were selected for grant awards through ordinance Nos. 183785; 183792; 183786; 183791; 183787; and 183784. The resulting grant agreements were executed on or about June 1, 2010. The original grant agreements all had the term of June 1, 2010 to May 31, 2013.
- In 2013, Council authorized amendments to the grant agreements extending the terms to June 30, 2015, as well as providing small increases in funding through ordinances Nos 186685 (NAYA); 186683 (El Programma); 186684 (IRCO); 186682 (YWCA); 186686 (EMO); and 186687 (BA).
- 7. In 2015, Council authorized amendments to extend the terms of the grants to June 30, 2017 through ordinance number 187330.

- 8. Five of the six grantees have capacity to continue to provide navigation services at the Gateway Center. Ecumenical Ministries of Oregon's Russian Oregon Social Services no longer has capacity to meet the grant responsibilities. It is in the best interest of the Gateway Center operations to extend the terms of the other agencies to maintain consistent and quality services that the community expects from the Gateway Center.
- 9. The cost to provide navigator/ advocacy services has increased. The new terms also reflect a cost increase of \$58,800 across the five grantees.

NOW, THEREFORE, the Council directs:

- a. The Commissioner-in-Charge is authorized to sign the grant amendments with the Grantees in substantial conformance with the ones attached as Exhibits A, B,C,D and E and approved as to form by the City Attorney.
- b. The grant funding for the additional navigator services will be from the Center's ongoing operations budget. \$574,000.00 will be dispersed to fund services through June 30, 2019.
