

ORDINANCE No. 188496

*Pay claim of Anthony Johnson in the sum of \$8,797 involving the Bureau of Transportation and Procurement Services (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Anthony Johnson has filed a claim against the City for unpaid benefits from a contract involving the Bureau of Transportation and Procurement Services.
2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the at this time.
3. Risk Management Services recommends the claim be compromised for the total sum \$8,797.16 subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$8,797.16 made payable to Anthony Johnson.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this property damage claim; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
