ORDINANCE No. 188498

* Authorize contract with Cardno, Inc. for on-call services for environmental review of transportation projects not to exceed \$150,000 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- The Bureau of Transportation develops federally funded transportation projects which require review and documentation to demonstrate compliance with the National Environmental Policy Act.
- 2. The Bureau of Transportation and Bureau of Purchases issued a Request for Proposals for on-call services for environmental review.
- 3. Cardno Inc. was the only qualified firm to respond to the RFP.
- 4. The Bureau's Level of Confidence for the proposed work is moderate, specific scopes will be determined on a project by project basis.

NOW, THEREFORE, the Council directs:

a. That the Commissioner-in-Charge is hereby authorized to approve a contract for on-call services with Cardno Inc. for environmental reviews of transportation projects substantially in accordance with Price Agreement attached as Exhibit A provided it is approved as to form by the City Attorney's office.

Section 2. The Council declares that an emergency exists because it is critical to complete environmental reviews for several projects to move the projects to bidding and construction; therefore; this ordinance shall be in full force and effect from and after its passage by the Council.
