

ORDINANCE No. 188510 As Amended

*Accept and appropriate a grant in the amount of \$20,000 from Oregon Department of Education for Expansion of the Summer Free for All Lunch Program (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

1. Portland Parks & Recreation applied to Oregon Department of Education for a grant in the amount of \$20,000 for Expansion of the Summer Free for All Lunch Program on *June 20, 2017*; and
2. Oregon Department of Education has notified the City of Portland that it will award a grant for the Expansion of the Summer Free for All Lunch Program to Portland Parks & Recreation in the amount of \$20,000;

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Department of Education for Expansion of the Summer Free for All Lunch Program in the amount of \$20,000.
- b. The FY 2017/2018 budget is hereby amended as follows:

- c. The Office of Management & Finance Grants Management Division is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- d. The Director of Portland Parks & Recreation of the City of Portland is authorized to accept on behalf of the City of Portland any subsequent

modifications by Oregon Department of Education for Summer Meals and Afterschool Meals & Snacks Program Start-Up/Expansion Grant, award number ODE265705, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.
