

ORDINANCE No. 188518

*Authorize a contract with Motorola Solutions, Inc. in the amount of \$14,000,000 to provide public safety communications equipment and related services (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Technology Services is responsible for the operation and maintenance of the City's public safety radio system. The system is utilized by Portland Fire, Portland Police, the Bureau of Emergency Communications, PBOT, BES, and over 80 outside agencies with public safety responder responsibilities within the region.
2. In order to properly maintain the City's public safety radio system, updates must be made regularly as new technology is introduced, and the system must be expanded and scaled to meet increasing user demand.
3. In 2007, the City entered into Contract #41105 with Motorola Solutions, Inc. for as-needed public safety radio equipment, software, and services.
4. City Charter limits the total term of such contracts to ten years. In accordance with City Code 5.33.220(D)(12), the City may directly enter into a contract for information technology hardware or software maintenance, licenses, subscriptions and upgrades without a competitive solicitation when obtained from the City's current provider in order to use the pre-existing knowledge of the vendor regarding the specifics of the City's system.
5. The City intends to continue the operation and maintenance of the public safety radio system, and desires to carry the terms and conditions of Contract #41105 forward as a new Contract #31001012, as amended by the City and Motorola Solutions, Inc.
6. The estimated cost for the purchase of public safety radio goods and services over a period of five years is approximately \$14,000,000.
7. The Bureau's confidence level in the estimated cost is optimum.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to execute a contract with Motorola Solutions, Inc. for as-needed public safety radio equipment, software, and related services for an initial term of five years and an amount not to exceed \$14,000,000, provided such contract has been approved as to form by the City Attorney's Office.

Section 2. The Council declares that an emergency exists because a delay would interrupt the ongoing support of the public safety radio system; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
