ORDINANCE No. 188550

Authorize an Intergovernmental Agreement with Peninsula Drainage District No. 1 and Multhomah County Drainage District No. for flood control stop log closure structures (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Portland Bureau of Transportation (PBOT) is the lead City bureau for flood control.
- MCDD and PEN 1 operate and maintain drainage and flood control systems in the vicinity of the Columbia River and that lie within their respective jurisdictional boundaries, among other duties. Through a prior IGA signed by the PEN 1 Board of Supervisors, PEN 1 delegates the management of its operations and administration of its contracts to MCDD.
- 3. In the early 1940s, the U.S. Army Corps of Engineers (USACE) constructed a floodwall with four traffic openings and removable Stop Log Closure Structures for flood control within PEN 1's jurisdictional boundary in North Portland. Each Closure consists of several removable concrete panels and steel beams.
- 4. As per past agreement with PEN 1 and MCDD, the PBOT Maintenance Operations group currently conducts all required routine and emergency installations and removals of the flood wall panels on behalf of PEN 1 and MCDD.
- 5. The terms of past agreement are the basis for the ongoing agreement of all parties. PBOT will therefore continue to take responsibility to install and remove flood panels per the terms of the attached agreement.

NOW, THEREFORE, the Council directs:

a. That the Commissioner-in-Charge is authorized to execute an Intergovernmental Agreement between the City of Portland and PEN 1 and MCDD in a form similar to the agreement attached as Exhibit A.


