# 6:30 pm—7:30 pm Case File Review: **Appeal 2013-C-0194/2014-X-0001 Appeal Summary:**

Allegation that that Officers A, B, C, and Sergeant D inappropriate force toward the appellant during his arrest on July 9, 2013

- Director Severe provided IPR side of the investigation:
  - o Appellant came to IPR office with his mother 12 hours after the incident
  - o IPR investigator was able to take photos of the appellant's injuries during the interview
  - IPR also collected the appellant's police "after action" report, VCAD information, video from MCDC, and a discharge report from Legacy Emanuel
- Investigator Accornero provided IA side of the investigation:
  - Incident was documented in the police report and the police "after action" report
  - Accornero received the case on August 21, 2013
  - Accornero received the intake interview transcript from IPR on August 27 and found some inconsistencies made by the appellant in his interview with IPR and needed to do a follow up interview
  - Accornero called the appellant on September 12 and 13 and left messages in an attempt to do a follow up interview
  - Accornero also sent a certified letter to the appellant to request a phone interview
  - Acconero was able to interview the appellant on September 16, but the appellant hung up half way through the interview
  - Accornero interviewed the involved officers on September 20
  - Accornero made attempts to call the appellant again on October 8 and 9
  - o Appellant left a voicemail on October 11 and requested to have his mother be present at the interview
  - Appellant's mother called on October 17 and try to setup an interview
- Appellant's mother Jeri Williams made some comments on behalf of her son:
  - o Police report said he was not injured when he has marks all over his body
  - She does not understand why her 105 pounds son was handled by 4 people
  - The allegation of excessive force should be that the police beat up the appellant up, not restrained him with a hobble
  - O Why did the appellant not receive any medical care after he was arrested?
  - o Ms. Williams would like to delay the appeal hearing until June
  - Ms. Williams also requested an APA and a representative from the National Lawyer Guild to help her son go through the appeals process

- The group is the process of formulating all the information into a recommendation to PPB

- Latoya Harris made an appeal to the CRC for advice on her 9 years old daughter's case. Her daughter was arrested by Portland police last year
- Ms. Hannon complimented the Outreach workgroup for reaching out to the homeless
- Mr. Handelman from Portland Copwatch had several comments:
  - The City responses to Judge Simon's questions regarding the length of time to hold an appeal asked for 45 days. He urged the CRC to push for a longer timeline
  - o The CRC meeting is not listed on the PPB community calendar under DOJ tab
  - o IPR and IA's key to identifying officers by letter (e.g Officer A, Sergeant B, etc.) need to be consistent to avoid confusion for CRC in conducting its appeals and the public in following the discussion
  - CRC should address the issue of Multnomah County Detention Center's camera no longer record audio to appropriate authority
- Ms. Aiona thanked Mr. Bissonnette for raising concerns regarding the outreach section in the Director's Report. She also thanked Chair Troy for his service on the committee
- Ms. Ross reminded the CRC that one of their roles is to recommend policy changes
- Mr. Brown urged CRC members to assign a liaison to the CPRC. The next CPRC meeting is April 16, 4:30 –
