Ordinance No 4348.

All Ordinance adopting the Report of the City Surveyor in the matter of the proposed Extension of South Front Street.

The City of Portland does Ordain as follows.

The Common Council deeming it expedient to extend the lines of South Front Street by cutting off a portion of Block No 106 in Caunters Addition to Caunters Addition to the City of Portland, so as to make a practical junction of the above named Street as laid out north of Woods Street, and that part of said Street which lies south of Woods Street, did on the 19th day of July 1884 direct the City Surveyor to survey the same, mark the boundaries thereof and make his report together with a plat showing each particular tract or parcel of land to be appropriated to public use, and the surveyor having made such survey report and plat which being satisfactory to the Common Council, - now therefore, the report of W. J. Chapman City Surveyor of the proposed Extension of South Front Street is hereby adopted of which said report the following is a copy: -

Gentlemen:

In pursuance of a resolution adopted at your meeting of the 19th instant directing me to survey an extension of South Front Street by cutting off a portion of Block No. 106 in Caruthers' Addition to Caruthers' Addition to the City of Portland, so as to make a practical junction of the above named street as laid out north of Woods Street and that part of said street which lies south of Woods Street, I have surveyed and marked the boundaries of such an extension of South Front Street, and herein submit my report, together with a plat, of such survey.

The proposed extension of South Front Street consists in removing its eastern boundary line between Woods & Grover Streets easterly, so as to include all that part of Block No. 106 in Caruthers' Addition to Caruthers' Addition to the City of Portland which lies west of a line thirty (30) feet in right measurement easterly from and parallel with a straight line drawn from the

point of intersection of the center lines of Grover and South Front Streets as laid out south of Woods Street to the point where the center line of that part of South Front Street north of Woods Street intersects a line thirty feet southerly from and parallel with the south lines of Blocks No. 45 and 56 in Caruthers Addition to the City of Portland.

The proposed extension of South Front Street will include and necessitate the appropriation to public use of the following described parts or tracts of Lots No. 5, 6, 7 and 8 in Block No. 106 in Caruthers Addition to Caruthers Addition to the City of Portland, to wit:

All that part of each of said lots No. 5, 6, 7 and 8 in said Block No. 106 in Caruthers Addition to Caruthers Addition to the City of Portland which lies west of a line thirty (30) feet in right measurement easterly from and parallel with a straight line drawn from the point of intersection of the center lines of Grover and South Front Streets as laid out south of Woods Street to the point where the

center line of that part of South Front Street north of Woods Street intersects a line thirty feet southerly from and parallel with the south of Blocks No. 45 and 56 in Caruthers Addition to the City of Portland, embracing four hundred and eighty five (485) square feet of the west of said Lot No. 5 in said Block No. 106; Nine hundred and ten (910) square feet of the west end of said Lot No. 6 in said Block No. 106; Thirteen hundred and thirty five (1335) square feet of the west end of said Lot No. 7 in said Block No. 106; and seventeen hundred and sixty (1760) square feet of the west end of said Lot No. 8 in said Block No. 106. All of said tracts or parcels of land so to be appropriated to public use being the property of G. G. Garrison
