ORDINANCE No. 188575 As Amended

*Accept and appropriate a Metro Nature in Neighborhood Capital Grant award to Portland Parks & Recreation in the amount of \$1,000,000 for the development of Gateway Green (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

1. Metro has notified the City of Portland that it will award Portland Parks & Recreation a Nature in Neighborhoods Capital Grant in the amount of \$1,000,000 for the development of Gateway Green.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a Nature in Neighborhoods Capital Grant from Metro for the development of Gateway Green in the amount of \$1,000,000.
- b. The FY 2017/2018 budget is hereby amended as follows:

GRANTS FUND

Fund – 217 Business Area – PK00 Bureau Program Expenses– \$1,000,000

- c. The Office of Management & Finance Grants Management Division is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- d. The Director of Portland Parks & Recreation of the City of Portland is authorized to accept on behalf of the City of Portland any subsequent modifications by Metro, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.

Section 2. The Council declares that an emergency exists because it is in the public interest to get the money accepted as quickly as possible; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
