WHEREAS, the committee has one vacancy resulting from the resignation of one member;

WHEREAS, a Selection Committee consisting of three Citizen Review Committee representatives, two members of the community, and the Assistant Program Manager of the Independent Police Review reviewed applications. A panel of one Citizen Review Committee member, one community member and the Assistant Program Manager interviewed candidates and recommended two applicants to serve on the Committee, one that filled a previous vacancy and another to hold in reserve for future vacancies;

WHEREAS, the City Auditor has now nominated the reserve candidate to City Council;

NOW, THEREFORE, BE IT RESOLVED, that the City Council for the City of Portland, Oregon appoints to the Citizen Review Committee new member Candace Avalos for a three-year term that will begin September 27th, 2017 and end September 26th, 2020.
