

AMENDMENT No. 7

* Increase a grant agreement with the YWCA of Greater Portland in the amount of \$30,000 to allow the YWCA to become a host agency for an Encore Fellow position at Gateway Center for Domestic Violence Services (Ordinance; amend contract No. 32000375)

RECITALS:

- A. Pursuant to an invitation to Submit a Request for Grant circulated publicly on or about April 15, 2010, City sought to provide grants to fund domestic violence victim-centered and culturally specific navigator/ advocacy services on site at the Gateway Center for Domestic Violence Services ("the Center"), located at 10305 E. Burnside Street, in Portland, Oregon.
- B. Portland City Council, through City Ordinance No. 183792, authorized a grant agreement with the YWCA of Greater Portland (Grantee), after Grantee was selected for a grant award based on its response to the invitation.
- C. The resulting Grant Agreement No. 32000375 was executed on or about June 1, 2010. The effective date of the Grant Agreement was June 1, 2010 to May 31, 2013.
- D. In 2013, the Portland City Council, through City Ordinance No. 185321, amended the original agreement and extended its term to June 30, 2014 (amendment #1).
- E. In 2014, the Portland City Council, through City Ordinance No. 186682, amended the original agreement and extended its term to June 30, 2015 (amendment #2).
- F. In 2015, the Portland City Council, through City Ordinance No. 187330, amended the original agreement and extended its term to June 30, 2017 (amendment #3).
- G. In 2015, the Portland City Council amended the original agreement again to include eviction prevention funding to address the housing state of emergency (amendment #4).
- H. In 2016, the Portland City Council again amended the original agreement to include additional eviction prevention funding to address the housing state of emergency (amendment #5).
- I. In 2017, the Portland City Council amended the original agreement to extend its term to 2019.
- J. The Gateway Center Advisory Council has set a priority of determining how to better serve elderly and disabled individuals at the time they seek court protections (restraining orders). However, space and staff limitations inhibit the

Center's current ability to provide services to those populations and simultaneously study their needs for additional services.

- K. Locally, a program run through Social Venture Partners Portland, known as the "Encore Fellows Program", matches talented and accomplished retirees with social justice organizations in order to improve their service capacity. Encore Fellows provide 1000 hours of service for a \$25,000 stipend.
- L. The YWCA is able to host an Encore Fellow that will be placed at the Gateway Center to provide restraining order assistance to elderly and disabled persons seeking such orders at the Gateway Center. The Encore Fellow will also study additional services needs for the population, and produce a report for policy-makers' consideration. The YWCA can provide host services for \$5,000 total.
- M. In 2017, the Gateway Center had a \$27,000 carry-over that was ear-marked to support an elder abuse expansion pilot program. \$30,000 in the FY 2017-18 budget is expected to be needed and available to fund the pilot program. Thus, \$3,000 is needed to close the gap on what is available and what the pilot program will cost.

Therefore, the parties agree as follows:

- 1. The recitals above are true and correct and are part of this Amendment No. 7.
- 2. The total grant funds to YMCA shall be increased by \$30,000 ("Additional Funds") to reflect the cost of the pilot project as outlined in the above Recitals.
- 3. The requested grant funds of \$30,000 will be used to host an Encore Fellow who will provide 1000 hours of service and study regarding elder and disabled populations.
- 4. Except as modified in Amendments No. 1, 2, 3, 4, 5, 6 and this Amendment No. 7, the terms and conditions of the Grant Agreement shall remain in full force and effect.

The parties have executed this Amendment No. 7 to Grant Agreement 32000375 in duplicate on the day and year written, and the corporate signature of Grantee being by authority of the Board of Directors of the executing corporation.
