ORDINANCE No.

Amend Vehicles and Traffic Code to authorize Portland Streetcar Supervisors and Superintendents to tow vehicles (Ordinance; amend Code Sections 16.30.100, .710 and .720)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 170923 and 187925 effective September 2, 2016, established that any parking enforcement officer, police officer, or other officer authorized by the City Council or by City Code may order a vehicle towed as provided by Title 16.30.100.
- Ordinance No. 175564 effective May 9, 2001, established City authority to move vehicles that block the operation of Portland Streetcar as provided by Title 16.30.710.
- 3. Ordinance No. 175564 and 179141 effective March 23, 2005, established any vehicle parked on a public right-of-way, or on City of Portland owned or operated property, may be towed according to the provisions of 16.30.730 upon the order of an authorized City official, or designee, without prior notice to the owner of the vehicle, when removal of the vehicle is required to provide clear access for operation of the Portland Streetcar, as provided by Title 16.30.720.
- Portland Bureau of Transportation (PBOT) seeks to clarify City Code authority of Portland Streetcar Supervisor/Superintendent to have vehicles towed pursuant to conditions of Title 16.30.100
- 5. PBOT seeks to remove reference to Portland Streetcar from Title 16.30.710 and 16.30.720 to avoid confusion over whether a vehicle is to be towed or moved.
- 6. The Bureau seeks to avoid confusion regarding whether a vehicle is being towed or moved; provide a clear process regarding the consequence of blocking operation of Portland Streetcar; and maintain reliable public transit operations for passengers.

NOW, THEREFORE, the Council directs:

a. City Code Sections 16.30.100, 16.30.710, and 16.30.720 are amended as shown in Exhibit A.
