Katz: roll call.

Francesconi: Here. **Saltzman:** Here. **Sten:** Here.

Item No. 1089.

Becky Swain: My name is becky swain I'm a member of crossroads which is a community organizing project of sisters of the road café. I live in portland, in southeast, I wanted to talk to you about the sit/lie ordinance. I wanted to just say that I feel like the issue's a lot bigger than just people on a sidewalk. You know, taking up too much space and I feel that the issue is a lot bigger than that involves the whole economy and the bigger picture affordable housing and things for people and resources which I know we do have and their not funded enough and you know where one agency refers somebody to another agency and another agency refers them back to where they started off from. And I just would like to be able to see there be more funds put into things like community centers for people where -- where people can just be and maybe have, you know, a resources, computers, educational opportunities, food, things that people need, peer counselors. There's a lot of creativity being thought up of by people and solutions other than just being able to call the police right off the bat or have the police come and, you know, take care of the situation. I find that the police are threatening and they make people feel intimidated. They don't help the situation at all. There's a lot of people that have real needs in life, I mean maybe some people go through school and everything works out for them and they -- everything -- you know, they do everything they're supposed to do and everything works out. That's wonderful, but that's just not the way it is with all people. There was even a reality that -- there is a reason to care about the 15% of people that are poor, because what if we get disease and we spread it to everybody else because of that bad health care, bad conditions, bad housing, things like that. That's why people don't want poor people around anyway, because, you know, there's something wrong with them, which there isn't, but, you know, that's -- that -- there is reasons why -- you know, there is a reason why poor people should be looked after. And I think that people have an inherent right of -- inherently are good and that people want to succeed, they want to fully develop as human beings, they don't want to just be schlepping along off the system or what have you. People want to be able to have a sense of pride in what they do, which is why work is good. You know, people don't need to not be working. I mean, it's good for people to work, feel self-respect and be able to contribute and participate and --

Katz: Thank you, becky. Your time is up.

Swain: Sure it is. But that's why I would like to see the ordinance changed into something more creative.

Katz: Okay, thank you. 1090.

Item No. 1090.

Moore: He's not here.

Katz: 1091.

Glenn F. Warren: My name is glenn warren, a volunteer representative of crossroads. This is kind of crazy trying to do this in three minutes where there's like no response, feedback. I'm going to try, though. It's hard to express the frustration that people are feeling when, you know, you say one thing and then your actions are contradictory. I watched your speech yesterday, very interesting, talking about community and working together. It's been quite a long time we've been working on this. Apparently there's been some secret work being done on this. You know, public process, that means including the public. You said last week when we were here that you were going to -- like I said, this is very frustrating -- that you were going to give us at a public hearing, which you came up with. You haven't even been involved yet. So what point were you trying to make yesterday? This is a very serious issue. I don't know -- i'd just like for the record to point out the scope of this issue. You put Portland on the map with the worst sit/lie/stand ordinance in america. This is a very serious issue, right? So like I said, this is very frustrating when you're saying one thing and doing another. There are a lot of organizations that do this because they choose this as a career, because they're concerned. People like me do it for free because they feel it's their duty to serve the community and make positive results happen. You're one of the people that's paid to do this. You have an obligation to fulfill this position that you're sitting in right now. By pretending that this is a public process, when you're only doing this behind closed doors with the d.a., the cops, the Portland business alliance, a special interest group, is ridiculous. So i've got 51 seconds. We want a round table. And a real round table. The one that I finally did get to go to, we weren't even allowed to talk about title 14. By the way, you weren't even there. Nobody was there from the commission -- none of the commissioners were there. So please don't continue to say ridiculous things. You know, they sound good, but you make them ridiculous with your actions. What are we supposed to do? Put up with it? I don't think so. Why should we?

Katz: Thank you.

Warren: Okay. I still have 14 seconds.

Katz: I'm sorry, you still have 14.

Warren: Yes. Crossroads is into building personal relationships and handling things sensibly. Please earn up to what you say and do.

Katz: Thank you.

Warren: Do it. Thank you.

Katz: All right. Let's do the consent agenda. Anybody want to take off the item off the consent agenda? Roll call.

Francesconi: Aye. **Saltzman:** Aye. **Sten:** Aye.

Katz: Mayor votes aye. [gavel pounding] 1094.

Moore: 1121?

Katz: I'm sorry. 1121.

Item No. 1121.

Saltzman: Madam mayor, members of the council, this represents continuing efforts to control flooding in the johnson creek floodplain watershed. We're pleased to bring in another 2.7-acre parcel located within the 100-year floodplain. It's shown in the map in your folders. We're proud of this program. Since 1997, we have passed more than 33 ordinances, the city council, and acquired 57 properties within the watershed. Taking these properties out of harm's way and putting them in their place, passive recreation opportunities, flood control and fish and wildlife habitat improvements. Most of the funding comes from a variety of sources outside the city, but some of this money is there through our sewer rate program as well. We wanted to highlight another three acres coming in.

Katz: Good work. Anybody want to testify on this? All right. Roll call.

Francesconi: That is terrific work, commissioner Saltzman, and to your bureau. Aye.

Saltzman: Aye.

Sten: It's great. Aye.
