

ORDINANCE No. 188672

*Rename a segment of NE Couch St to NE Couch Ct (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. NE Couch Street between the Willamette River and NE 12th Avenue was dedicated as public right-of-way on the Plat of "East Portland" dated April 10, 1865 and recorded in Book 1, Page 54, Multnomah County Plat Records.
2. A remnant segment of NE Couch Street east of NE 3rd Avenue was left upon completion of the Burnside/Couch Couplet (the "Street Segment").
3. On April 23, 2014, City Council passed Ordinance No. 186539 to form a Local Improvement District ("LID") to construct improvements with the Street Segment.
4. On May 24, 2017 and in connection with the LID, Ordinance No. 188400 passed City Council vacating 2 small portions of the Street Segment (the "Street Vacation"). The Street Vacation together with the street dedication that occurred in 2014 realigned the Street Segment.
5. Due to the realignment of NE Couch Street and with the LID and Street Vacation being completed, to avoid further confusion, it is necessary to rename the Street Segment to NE Couch Court thereby distinguishing the difference from NE Couch Street.
6. It appears that no properties will be affected by renaming the Street Segment; the 2 property owners abutting the Street Segment have been informed and are supportive of the renaming. Multnomah County has also been notified.
7. This request complies with the procedures and requirements established in Title 17, Chapter 17.93.050, Council-Initiated Action to Rename a City Street.

NOW, THEREFORE, the Council directs:


- a. The renaming of the Street Segment from NE Couch **Street** to NE Couch **Court** as depicted on Exhibit A attached and incorporated by reference is approved.

Section 2. The Council declares that an emergency exists because a delay in officially renaming the Street Segment would further confuse emergency responders in locating properties impacted by the name change within the Street Segment; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
