

ORDINANCE No. 188699

*Authorize a Special Appropriation grant agreement with the African Youth and Community Organization in an amount not to exceed \$27,800 to expand the youth coordinator position (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The African Youth and Community Organization is expanding their youth coordinator position to help provide increased cultural and linguistic specific support to African immigrant and refugee youth in Portland.
2. Through the coordination of education, athletics, integration focused programs and through communication with participants' families and teachers. AYCO's youth coordinators will build on a thoughtful approach to the needs, strengths and aspirations of African immigrant youth in Portland, to help them better transition to life in their new city and country.
3. AYCO began working with immigrant and refugee youth in Portland in 2009, developing opportunities for mentorship and sport activities. The need for more comprehensive family and community support has prompted AYCO towards family mentorship, parent-school mediation, cultural brokering, and providing programs for African youth of all abilities.

NOW THEREFORE, The Council directs:


- a. The Mayor is hereby authorized to enter into a grant agreement, with the African Youth and Community Organization, as outlined in a form substantially in accordance with agreement attached as Exhibit A, at a cost not to exceed \$27,800.
- b. The Mayor and Auditor are hereby authorized to draw and deliver payment chargeable to Fiscal Year 2017-2018 Budget.

Section 2. The Council declares that an emergency exists because a delay in funding could result in a delay in services; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
