ORDINANCE No 188703

*Amend an Intergovernmental Agreement with the Oregon Department of Transportation for local agency certification (Ordinance; amend Contract No. 33000146)

The City of Portland ordains:

Section 1. The Council finds:

- The City of Portland entered into an agreement with the Oregon Department of Transportation on Feb 10, 2006 to enter into the ODOT Local Agency Certification Program. (Agreement No. 52582)
- The Local Agency Certification Program allows for the Bureau of Transportation and other city bureaus to design and construct transportation projects funded by the Federal Highway Administration. The City entered the program on a test basis
- On July 11, 2012 the City and ODOT entered into an updated agreement acknowledging that PBOT is fully certified in design, advertising, bid and award, and contract administration. This agreement was approved by City Council on July 11, 2012 by Ordinance No. 185481. (Agreement No 33000090)
- 4. On August 26, 2015 Council approved a revised agreement in accordance with new requirements from the Office of Management and Budget (Ord. No. 187311)
- 5. This amendment modifies the existing agreement to allow for the City of Portland to use its own procedures to demonstrate compliance with the Americans with Disabilities Act.

NOW, THEREFORE, the Council directs:

a. That the Commissioner-in-Charge is hereby authorized to approve Amendment #1 to the Local Agency Certification Agreement with the Oregon Department of Transportation and delegates future approvals to the Director of Transportation.

Section 2. The Council declares that an emergency exists because *this is an* administrative change that affects several time critical projects, therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
