

## ORDINANCE No. 188705

\*Authorize a contract with the lowest responsible bidder for the Foster Streetscape Project, SE 50<sup>th</sup> to 92<sup>nd</sup> Ave (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Foster Streetscape Project, SE 50<sup>th</sup> to 92<sup>nd</sup> Ave implements the Foster Rd Transportation and Streetscape Plan, adopted by City Council in 2014 (Resolution No 36158).
2. In 2015, the Portland Bureau of Transportation (PBOT) entered into a funding intergovernmental agreement with the Prosper Portland for \$1,940,156 and the Oregon Department of Transportation through a federal grant to design and construct the project.
3. Additional funding for the project comes from the Fixing Our Streets Program to repave Foster Rd, \$3,000,000 and PBOT's Transportation System Development Charge Program, \$600,000.
4. Project design is completed and now PBOT is proceeding with bidding the project for construction.
5. The Bureau of Transportation has funds budgeted in FY 17/18 and 18/19 for construction, inspection and management of the project.
6. The Bureau's level of confidence in the cost estimates for this project is moderate, as plans, specifications, and estimates are now completed and the project is ready for bidding.

NOW, THEREFORE, the Council directs:

- a. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's office.
- b. The Auditor to draw and deliver warrants chargeable to T00382 when demand is presented and approved by the proper authority.


