Appointee: Laura Young

Bio:

Appointed to CNAC in 2011. Laura has also been elected by CNAC to serve in leadership roles and currently serves as Board Chair of the Cully Association of Neighbors, which is one of the close-in neighborhoods adjoining PDX. As a non-aviation and community organizer Laura has consistently brought her unique perspective to help inform the group's dialog and decision-making.

Personal Statement:

Since moving to the Cully neighborhood in 2004 I have become increasingly engaged in neighborhood advocacy and represent both the Cully Neighborhood and surrounding neighborhoods in many aspects of social equity, infrastructure development and livability concerns. I have been an active participant in the Cully Association of Neighbors (CAN) since 2009, serving as Land Use and Transportation Chair for six years, presently as the CAN Board Chair, and have represented the City of Portland as a member of CNAC since 2011.
