Purpose of proposed legislation and background information:

This appointment will fill one of the six positions on the River Community Advisory Committee (RCAC) as required by Portland City Code Title 28.03.015.

Financial and budgetary impacts:

This legislation appoints a citizen volunteer to serve on the RCAC, and will therefore have no budgetary or long-term financial impacts for the Bureau of Development Services (BDS) or the City.

Community impacts and community involvement:

The Bureau of Development Services continually advertises positions for the board through its webpage and, as needed, Media Announcements of upcoming positions. These Media Announcements are widely circulated in the design, development and neighborhood community news outlets and web pages.

Subject: Appointment to River Community Advisory Committee (RCAC)

The River Community Advisory Committee is a citizen advisory body, composed of six members who represent a variety of floating structures interests. Members are appointed by the Mayor and confirmed by the City Council for three-year terms and will serve no more than two complete three-year terms, unless the Director recommends approval of a longer term and the Mayor and City Council approve the extended appointment, as specified in Portland City Code Title 28.

I am recommending Terry Glenn for a first, 3-year term from November 29, 2017 to expire on November 28, 2020. Terry has extensive experience as a floating home resident, yacht club member, and active participation in local and regional community and floating home development boards, forums, and quality control efforts.
