

ORDINANCE No. 188728

* Amend contract with Speer Hoyt LLC in the amount of \$75,000 for outside legal counsel services in the interest arbitration with Portland Fire Fighters Association (Ordinance; amend Contract No. 30005844)

The City of Portland ordains:

Section 1. The Council finds:

1. The City required the services of outside legal counsel to co-counsel with the City Attorney's Office in the interest arbitration between the City and Portland Fire Fighter's Association.
2. The law firm of Speer Hoyt LLC agreed to provide those services by Legal Services Agreement No. 30005844 dated June 13, 2017.
4. Due to the complex nature and length of the interest arbitration hearing, it is necessary to increase the amount of this contract

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to extend Legal Service Agreement No. 30005844, dated June 13, 2017, to provide for representation by outside counsel in an additional amount of \$75,000, for a total not to exceed \$150,000.
- c. If applicable, the provisions of City Code Chapter 5.68 are waived.
- d. The Mayor and Auditor are authorized to draw and deliver checks in payment of legal services provided under this Legal Services Agreement.

Section 1. The Council declares that an emergency exists in order to continue to pay for legal services in a timely manner for the services rendered by Speer Hoyt LLC in the interest arbitration; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


