ORDINANCE No. 188730

*Pay claim of Farhad Roshanaie in the sum of \$51,500 involving Portland Parks and Recreation. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Farhad Roshanaie, through attorney Andrew Altschul, has filed an employment practices claim against the City related to his employment which ended on March 31, 2017.
- 2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid an adverse jury award, we feel it is prudent to compromise the claim at this time.
- 3. Risk Management Services recommends the claim be compromised for the sum of \$51,500.00 subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$51,500.00 made payable to Farhad Roshanaie and Buchanan Angeli Altschul & Sullivan LLP.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this employment practices claim; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
