

ORDINANCE No. 188738

*Amend contract with Axiom Event Productions, LLC for volunteer and course management services through the Portland Sunday Parkways program for an amount not to exceed \$149,500 (Ordinance; amend Contract No. 30003708)

The City of Portland ordains:

Section 1. The Council finds:

1. Portland Bureau of Transportation (PBOT) Vision calls for a balanced, multi-modal transportation system where residents will have a broad range of safe and convenient transportation options and will frequently walk, bicycle, carpool, or ride public transit as their first choice of transportation.
2. Portland Sunday Parkways promotes healthy active living through a series of free events opening the city's largest public space -- its streets -- to walk, bike, roll, and discover active transportation. Portland Sunday Parkways fosters civic pride, stimulates economic development, and represents the community, business and government investments in Portland's vitality, livability, and diversity.
3. Each year, Portland Sunday Parkways events draw approximately 100,000 participants and garners significant media coverage. The City of Portland and its partners plan to implement five annual Sunday Parkways events in 2018, which promote walking & bicycling.
4. Axiom Event Productions, LLC. was selected through a competitive bid process to provide volunteer and course management services for five Sunday Parkways engaging more than 300 volunteers at each event.
5. In 2017/18 budget, City Council dedicated funding for Sunday Parkways through the General Fund that will be supplemented with funding from sponsorships, fees and individual contributions for the 2018 calendar year.
6. The Bureau's level of confidence in the cost estimates for this project is optimal.

NOW, THEREFORE, the Council directs:


- a. That the Commissioner-in-Charge is hereby authorized to amend Contract No. 30003078 with Axiom Event Productions, LLC, in a form similar to the contract attached as Exhibit A.

Section 2. The Council declares that an emergency exists because the current contract amendment expired on October 31, 2017; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
