We were a part of the pilot project to include food in the yard debris and change to every other week garbage collection. We increased automation collection and transitioned from cans to roll carts, we have gone above and beyond in the clean fleet program by investing in clean natural gas vehicles and also making a huge investment in a natural gas fueling station.

Through hard work, dedication, and continuous investment over many years, we have been able to grow our company and provide the quality service to our customers in a cost effective way that they deserve. This also allows us to expand and add our third generation of Heibergs, which includes my two nephews and niece, all of whom are working at HGR.

We are not a large company but by reaching out and approaching other companies we have been able to expand and grow over the years – for example, we negotiated the purchase of Cloudburst Recycling less than two years ago. We have grown from one truck and one employee to the family owned business we are today.

We are proud of the family wage jobs we are able to provide as well as the diversity of our work force and the quality of service our team provides to our customers. HGR will continue to provide employment opportunities for people of color and women, as we view that as a crucial aspect of our company culture. If you review the franchise diversity workforce data provided by Jeremy Hays, a Consultant hired by the City, you will see that the Portland Hauler workforce is already in line with Portland's total workforce, and we will continue to strive to increase our diversity.

We have worked tirelessly and cooperatively with the City and its consultants during this periodic franchise review. We cannot do the work we do without the renewal of the franchise, and we sincerely ask for your support. With renewal, we may continue to make the long term financial decisions and investments needed to upgrade our fleet to compressed natural gas and to improve the service we provide to the citizens of Portland.

My name is Andy Kahut, I reside at 30906 S. Needy Rd. Canby, OR 97013. I write to share the story of our second-generation family-owned business, and to ask you to support the renewal of the City of Portland's residential solid waste and recycling collection franchise.

The majority of our company is women-owned: my mother, Nancy, is our Vice President and the co-founder of our companies; my sister, Pam, is our CFO and oversees all of our internal accounting, annual rate review process and customer service; my sister, Julie, is our CEO and manages our accounts payable, franchise fees, taxes and audits. Rounding out ownership, my brother, Ray, is our COO, heading up daily operations and human resources and I serve as the President. Together, we own City Sanitary Service here in Portland as well as three other collection companies, a processing center and a transfer station in Clackamas County.

My parents, Fred and Nancy Kahut, purchased their first single-truck collection route in 1967, right here in Portland. My father worked long hours growing his business and making many long-term relationships in the industry. He served on many solid waste and recycling organizations and committees in Portland and throughout Oregon. Through these relationships, he grew our business from one truck to over 50. We now serve over 30,000 residents and 2,000 businesses in the Portland-Metro-Tri County area. On January 1, 2018, we are purchasing Mel Deines Sanitary Service, Inc., which borders City Sanitary Service and holds a City of Portland solid waste and recycling collection franchise.

Growing up in the solid waste and recycling industry, as my family has, is unique. For example, we have always worked every holiday except Christmas and New Year's Day. Every Martin Luther King Jr. Day, Presidents' Day, Memorial Day, 4th of July, Labor Day, Veterans' Day and Thanksgiving were spent at work. This is who we are-service providers. Except for the occasional winter blizzard, we go to work and serve our customers. We wouldn't have it any other way.

We also own a regional processing center which includes both a Clean and Dirty MRF (a Material Recycling Facility that sorts recyclable materials from waste). In fact, in 1992, we received a call, late in the day, asking (more like begging) for our MRF to stay open for 24 hours for a few days as Portland haulers were overwhelmed with the start of curbside recycling and needed a place to empty recycling trucks throughout the night. Of course, we stayed open-this is a partnership-and, as you know, the program has grown into a national success.

We have always employed a diverse staff and many employees have worked their way through college and life. Some have gone on to become dentists, fire fighters, school teachers and ministers; others have stayed with us throughout their working lives. Early next year, we will retire a 42-year employee. We currently employ over 70 Oregonians in family wage jobs. We live here, work here, and spend our money here. As you can see, this franchise renewal is more than just our business, it is our life! We are all-in. We consider it an honor and privilege to work in Portland and we depend upon the renewal of our franchise to continue this great work!

Hello, my name is Dave Cargni, I am a stockholder who also serves on the Board of Directors as the Secretary and Treasurer of Portland Disposal & Recycling.

Portland Disposal & Recycling (PDR) is a family owned and operated business that dates back over 95 years servicing customers in the City of Portland. The company started in 1922 with the grandfather of one of our business partners picking up trash with a horse-drawn wagon. Today, we consist of seven principal owners that each have had a minimum of 38 years in the business. All of these owners have purchased routes and have made sacrifices both personally and financially to provide the best garbage and recycling service to the citizens of Portland. In keeping with diversity, our company currently has three women stockholders, one who is Vice President and office manager. Our CFO and operations manager is Hispanic.

Our company employs and supports 85 families from many diverse ethnicities, religions and genders. It is our goal to expand our workforce diversity and find creative way to reach out to potential employees. For example, we advertise job opportunities in our customer billings. We also offer commercial driver training to all new hires.

When the City of Portland decided to create a residential franchise system in 1992, the haulers worked together to help the City create an efficient collection system that has been a benefit to every citizen in Portland. Working together, we have provided a state-of-the-art recycling and garbage collection system.

Over the years, several haulers have sold their businesses and retired with the value of that business as their retirement; PDR has incurred risk and debt to purchase 13 residential routes and businesses in the past 26 years. The businesses that PDR and others purchased were owned by varying ethnicities, including four African American-owned companies (PDR bought two of those businesses) along with companies owned by people of German and Italian descent, among others. All were hard-working American families.

Our shareholders have risked everything they own to build this company and strongly support a renewal of the franchise agreement to allow us to continue to move forward and make the investments needed to meet the City's future needs and goals.

Hello, my name is Carla Scheafer. Along with my brother, Steve Schwab, we own and operate Sunset Garbage Collection Inc. which is a third generation family-owned small business - we purchased it from our parents, who purchased it from our grandparents. We've been doing business in Portland for almost 100 years and currently provide solid waste, recycling, yard debris, and compost services to just over 1600 residential, commercial, and multi-family customers.

My grandfather founded Sunset Garbage in 1919 as a one-man route in lower southeast Portland. It was 1934 when a small country trailer park located on SE 82nd and Harney St was in need of service and no other garbage company was willing to venture out that far to serve them. As my grandfather built his customer base further out of town, this route was called his "Saturday" route; my parents purchased it from him in the mid-1950s. The trailer park that took our company to outer southeast Portland still exists today and is still a customer of Sunset Garbage.

Over the years there have been a lot of changes in the solid waste industry. In 1992, the City of Portland adopted a residential franchise system that incorporated all the haulers at that time. This system has made it possible for the haulers and the City of Portland to work together and to achieve many goals related to solid waste reduction, increased recycling, better sustainability, and safety. These achievements have helped to improve our city's livability, better serve the citizens of Portland, and assist in the wellness and longevity of our employees.

Because I was raised, live, and work in the same local area, I feel very connected to my community. I also have a very strong and inherent bond to my family business. Even though we only serve a small area within the City of Portland, Sunset Garbage takes great pride in providing the highest quality of service to our customers and in providing safe and rewarding work conditions for our employees. We were the first company in the City of Portland to provide roller carts to our customers for yard debris service, and to fully automate our fleet and fully cart our customers. I appreciate that I am able to live, work, and play within the same community. There's nothing better than to chat with a customer who has had our service for over 30, 40, even 50 plus years.

I am proud to be a female in what was considered a male-dominated industry. Although, I still get some funny looks when I tell people that I own a garbage company... I can tell you that women are not only active in the daily workforce, management, and ownership within our solid waste system, but that they are active in leadership and guidance throughout our industry as well. I have watched three different women serve as president to our state association, Oregon Refuse and Recycling Association. Our current Executive Director for ORRA is Kristan Mitchell. I have worked alongside women on both local jurisdictional boards and advisory committees. Our current president for the Portland Haulers Association is Valerie Gruetter Hill.

I too, hope Mayor Wheeler and the council members see how well that the partnership which was developed 25 years ago is still serving the citizens of Portland. With the renewal of this periodic franchise review, we will continue our partnership and achieve additional goals to further improve the residential solid waste system within the City of Portland.
