

## ORDINANCE NO. 153070

An Ordinance accepting a Land and Water Conservation Fund Grant in the amount of \$95,000 from the Department of the Interior for construction of an orientation center in Marquam Nature Park, increasing resources and requirements in the Federal/State Grants Fund and the General Fund, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Council authorized the Park Bureau to apply to the Department of the Interior, National Park Service, through the Oregon State Parks Division for a \$95,000 Land and Water Conservation Fund Grant for improvements to Marquam Nature Park by Ordinance No. 151452.
2. The Park Bureau applied for and was awarded this grant using an offer of donation from the Friends of Marquam Nature Park of \$100,000 worth of property adjacent to Marquam Nature Park as the required local match.
3. Based on award of the grant and the Park Bureau's need for the commensurate appropriation authority to implement the project, \$95,000 should be appropriated in the Park Bureau, Planning and Development, BUC 13911908.

NOW, THEREFORE, the Council directs:

- a. The grant specified in paragraph 1 above is hereby accepted.
- b. The budget is amended as follows:


