Section 1. The Council finds:

- 1. The Bureau of Environmental Services (BES) is rehabilitating aging and deteriorating sewer pipes adjacent to Jackson Tower building on SW Yamhill street.
- 2. BES requires an Agreement with Jackson Towers Partners for private plumbing reroute during public sewer rehabilitation. Terms and Conditions of this Agreement include among other items; Obligations and Provisions.
- 3. There is no cost associate with this agreement.
- 4. Jackson Towers Partners' attorneys have required an article of indemnification in the proposed agreement.
- 5. Council authorization is required for the proposed indemnification article in the agreement.

a. The Director of BES, or his designee is authorized to execute the agreement with Jackson Towers Partners for the purposes described in Section 1 and as attached in Exhibit A, provided the agreement has been approved as to form by the City Attorney's Office.
