ORDINANCE No. 188756

*Authorize a grant agreement with Allen Temple Church in an amount not to exceed \$30,000 for their Community Outreach and Emergency Services Program in North and Northeast Portland (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Allen Temple Church has been a community-oriented church serving the North and Northeast Portland communities through dynamic outreach programs. Such as, providing counselling services, and referrals for people living with HIV/AIDS, homeless outreach and social justice training.
- 2. Through their partnership with the Oregon Food Bank, Allen Temple Church offers and accessible food bank and served over 1,400 community members last year. The food bank is opened 15 days a month and is one of the few that offers this many hours of service to the community.
- 3. Located in one of the oldest neighborhoods in Northeast Portland, Allen Temple has been a pillar in the community with many neighbors having long-term relationships with the church. Allen Temple believes in empowering their neighbors by offering them opportunities to have a voice and be recognized as members of the community regardless of disparities or barriers they may face.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to enter into a grant agreement, with Allen Temple Church, as outlined in a form substantially in accordance with agreement attached as Exhibit A, at a cost not to exceed \$30,000.
- b. The Mayor and Auditor are hereby authorized to draw and deliver payment chargeable to Fiscal Year 2017-2018 Budget.

Section 2. The Council declares that an emergency exists because a delay in funding could result in a delay in services; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
