# ORDINANCE No. 188768

\*Amend Marsh ClearSight LLC contract by \$337,426 over five years for claims administration software (Ordinance; amend Contract No. 3002913)

The City of Portland ordains:

#### Section 1. The Council finds:

- The Risk Management Division (Risk Management) of the Bureau of Internal Business Services is responsible for self-insured and self-administered claims for workers' compensation, auto and general liability, as well as commercial insurance placement and first party claims oversight, occupational health and infectious disease, employee safety and loss prevention services.
- 2. Marsh ClearSight LLC (Marsh) provides automated claims administration software that enables Risk Management to expedite claims management, ensure compliance with policy requirements, and consolidate reporting on claims management activities.
- 3. The City selected the Marsh software through RFP No. 113204, and executed Contract No. 30002913 with Marsh on September 24, 2012 for its implementation, licensing, and maintenance.
- Risk Management desires to extend Contract No. 30002913 with Marsh for ongoing software licensing, maintenance, and related services.

### NOW, THEREFORE, the Council directs:

The Chief Procurement Officer is authorized to execute an amendment to Contract No. 30002913 to increase the not-to-exceed value by \$337,426.15 for a new total not-to-exceed amount of \$931,051.15 for ongoing software licenses, support, and related services, provided the contract has been approved as to form by the City Attorney's Office.

Section 2. The Council declares that an emergency exists because a delay in proceeding with this contract may result in additional expense and delay in providing citywide claims administration services; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
