

ORDINANCE No. 188782

\*Authorize a grant agreement with East Portland Neighbors, Inc. in the amount of \$12,000 for the production of the East Portland Neighborhood Newsletter (Ordinance)

The City of Portland ordains:

SECTION 1. The Council finds:

1. The City of Portland, Office of Neighborhood Involvement (ONI) funds the East Portland Neighborhood Office (EPNO), a city-administered neighborhood office, to support outreach and information sharing between EPNO community partners which includes identity-based community groups, neighborhood associations, and the community at large in East Portland.
2. Funding was adopted by the City Council as part of the FY 2017-18 ONI budget and is funded with a total of \$12,000 through City General Fund dollars. City Council adopted Community Connect, a Five-Year Plan for Increasing Community Involvement on February 17, 2008. Under recommendation three, the plan called for promoting effective communication to keep the community informed about issues and opportunities for involvement by facilitating communication through print newsletters and other means.
3. A \$12,000 grant is going to East Portland Neighbors (EPN) for production of four issues, published during the 2017/2018 fiscal year, of the *East Portland Neighborhood News*, a coalition-wide print newsletter for the purpose of encouraging and facilitating communication in East Portland.

NOW, THEREFORE, the Council directs:

- a. The Director of the ONI is authorized to execute a grant agreement on behalf of the City in a form substantially in accordance with Exhibit A in the amount of \$12,000.
- b. Amendments to the grant agreement may be agreed to and executed by the Director of ONI or the director's designee provided those amendments do not increase the fiscal risk to the City.
- c. The Mayor and the City Auditor are hereby authorized to pay for said grant agreement from the Office of Neighborhood Involvement general funds.

SECTION 2.




