ORDINANCE No. 188783

Authorize Portland Parks & Recreation to execute Parks Allocation Certification Agreements and accept annual grant awards from the Oregon State Marine Board for maintenance of boating facilities (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- The Oregon State Marine Board provides allocations for maintenance of boating facilities through their Maintenance Assistance Program (MAP). Parks and Recreation. Portland Parks and Recreation is responsible for four facilities which qualify for allocations from MAP.
- 2. This is a continuing, annual grant by MAP pursuant to the "City of Portland, Parks Allocation Certification Agreement Maintenance Assistance Program" (the 2017 Agreement is attached as Exhibit A) and Portland Parks & Recreation must be authorized by Council to execute that Agreement and accept the grant funds.
- 3. MAP has allocated \$19,950 for the fiscal year period of July 1, 2017 to June 30, 2018, and it is anticipated that MAP will allocate similar amounts for maintenance of boating facilities in the City of Portland in future years.

NOW, THEREFORE, The Council Directs:

a. The Mayor, or the Mayor's designee, is hereby authorized to execute a document similar to Exhibit A, the "City of Portland, Parks Allocation Certification Agreement Maintenance Assistance Program, 2017", and accept the grant award of \$19,950 for maintenance at boating facilities from the Oregon State Marine Board Maintenance Assistance Program, in Fiscal Year 2017-18. The Mayor, or the Mayor's designee, is also authorized to execute that same form of agreement in any following year in which funds from this grant are available, provided that the City of Portland, Parks Allocation Certification Agreement Maintenance Assistance Program for each fiscal year is approved as to form by the City Attorney's Office.
