

**ORDINANCE No. 188815**

\*Create a new represented classification of Parks Associate and establish a compensation range for this classification. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is creating a new represented classification effective October 5, 2017.
2. The business needs that this classification is intended to meet cannot be fulfilled until the classification and wage rate is established. The wage rate for this classification was collectively bargained with Laborers Local 483-Recreation.

NOW, THEREFORE, the Council directs:

- a. The following classification is being created:


<u>Job Class</u>	<u>Effective Date</u>

- b. The following compensation range is established:

<u>Minimum Rate</u>	<u>Maximum Rate</u>
\$12.00	\$20.00
