The main floor has a living room, large dining room, kitchen with double sink, formica drainboards and small pantry, 1 bedroom, large, and entry hall. Attic area has 3 bedrooms and old style bath. There is a full basement with dirt floor, concrete walls, and new type FHA piped oil furnace. Interior is of lath and plaster, fir and linoleum floors and fir trim. Exterior is of asphalt shingles, composition roll roof, and GI gutters. There is no garage. The home is in fair average condition.
