

ORDINANCE No. 188819

*Pay property damage claim of Randall Wilkes in the sum of \$10,715 involving the Portland Police Bureau (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Randall Wilkes through his insurance carrier, Nationwide, has filed a property damage claim against the City for damages suffered in a motor vehicle collision involving the Portland Police Bureau on October 31, 2016.
2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claim at this time.
3. Risk Management Services recommends the property damage claim be compromised for the total sum of \$10,715.20 with the amount of \$10,215.20 still due.

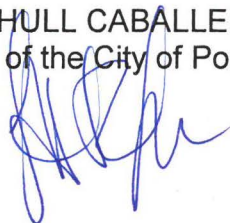
NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$10,215.20 made payable to Nationwide Insurance.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this property damage claim; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
