

ORDINANCE No. 188822

* Authorize a grant agreement with Fair Housing Council of Oregon in an amount not to exceed \$34,480 to support the Hate has No Place in Housing project. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Fair Housing Council of Oregon (FHCO) is a non-profit civil rights organization whose mission is to end housing discrimination and ensure housing opportunity statewide.
2. FHCO's education, outreach, enforcement, and advocacy efforts always to a degree have included efforts to end hate and harassment in housing.
3. FHCO recognizes that many forms of hate can manifest itself in acts of housing discrimination, whether individual or institutional, intentional or unconscious. Their mission is focused on ending housing discrimination so their work always has been based in confronting hate and discrimination.
4. The political environment of the past year increasingly has created an environment where hate whether expressed through speech, vandalism, or other physical acts continues to find its way into housing.
5. Two data points best convey the urgent need around housing-related hate and harassment incidents in Portland. First, the number one location where hate crimes occurred was in or near a home. Second, Oregon led the nation in hate incidents, per capita, with half reported in Portland.
6. The FY2017-18 budget includes funding in the General Fund Special Appropriations for the above grant. The City now desires to make a grant to Fair Housing Council of Oregon in an amount not to exceed \$34,480.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to enter into a grant agreement with the Fair Housing Council of Oregon, as outlined in a form substantially in accordance with the agreement attached as Exhibit A, at a cost not to exceed \$34,480.
- b. The Mayor and Auditor are hereby authorized to draw and deliver payment chargeable to the Fiscal Year 2017-18 Budget.




