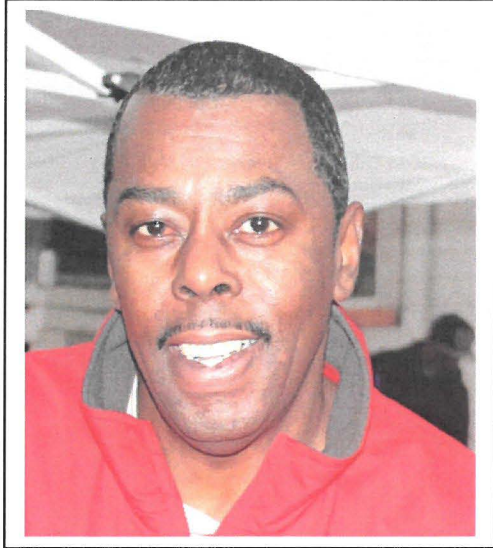
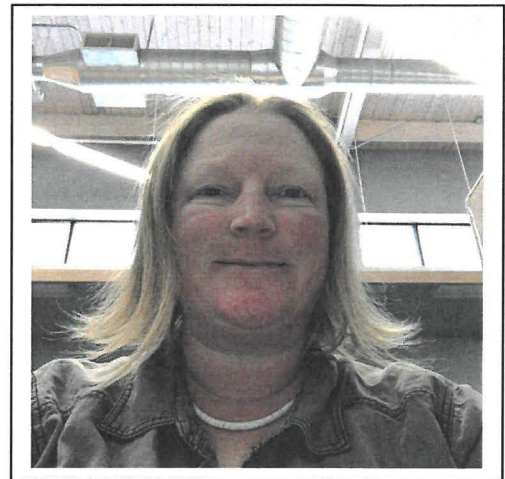


Noise Review Board Appointments
