- SUBJECT: Accept recommendations of the Special Appropriations Committee, for grant awards, from the \$350,000 allocated to the FY17/18 competitive special appropriation program during The Fall Bump process.

The Special Appropriations Committee is pleased to recommend the following ten organizations for funding from the \$350,000 allocated to Fiscal Year 2017/2018 competitive special appropriation program, during The Fall Bump process.

The committee picked up where they left off after allocating the first \$650,000 among seventeen organizations. However, of these seventeen, the committee voted to rescind the funding from The Rebuilding Center. The reason being, The Rebuilding Center decided not to pursue the feasibility study for which they were originally awarded funding. The committee did not think it was fair to the other applicants to allow a resubmission at this point in time. The \$45,000 taken from The Rebuilding Center was added to the \$350,000 allocated during The Fall Bump, bringing the total amount to \$395,000.

Each application was ultimately awarded an overall score out of 70 total points by each committee member. Using these scores, the committee narrowed down the applications for discussion. There were several instances where the committee thought an organization should be awarded funding, but through another funding source, such as the City budget process. As the committee assessed the scalability of the applications, additional information was requested from several applicants. Ultimately the committee reached consensus on the proposed recommendation.

Applications were received from organizations that have never received funding from the City, as well as those with historic partnerships with the City.

As this is the second year of awarding funds through this method, it was important to allow the committee flexibility as questions and issues arose. With that in mind, the committee suggests the following changes to improve the process and better outline expectations for future appropriations of this nature:

• An organization may only submit one application

- Have an informational section prior to the start of the application process to inform applicants of the requirements for receiving funding from the City
- Only organizations providing services within the City would be eligible for funding
- Organizations not currently receiving City funds will be given priority consideration
- Begin the application process earlier in the year to better align with the Budget Adoption timeline and the start of the City's fiscal year

We hope this group of awardees accurately represent the goals and values of the City of Portland, and we encourage the Council to continue with this process in upcoming fiscal years.
