Mayor Wheeler and City Councilors – My name is Merilee Karr. I am the Team Leader of the Neighborhood Emergency Team, or NET, in South Burlingame, the neighborhood of the proposed development.

My concerns are my own. I do not speak for the Portland Bureau of Emergency Management, which runs the NET program.

NET members are volunteers, trained by Portland Fire & Rescue as amateur first responders. We can and will be on the scene of disaster before professionals with heavy equipment arrive.

As I assess hazards around my neighborhood, I look at houses set on slide-prone ground as **coffins**.

These houses, on unstable land that has slid before, **will** sooner or later give way, in a big rainstorm or an earthquake. Building the proposed development will further increase the precariousness of this slope, by removing the trees whose roots are now holding the soil in place.

NETs are trained to extract people from rubble, but not from mud. If you allow these coffins to be built, my team will be there when they slide, trying to save our neighbors' lives—and living ever afterward with memories of partial success, if any.

My neighborhood holds other coffins, too, structures that pose extreme seismic danger. They are homes built of unreinforced masonry, or URMs. They will collapse in a strong earthquake, threatening lives both inside and outside the house with a rain of bricks.

No one can build URMs anymore, because Portland's seismic vulnerability has, literally, made itself felt. Our vulnerability to landslides is also well-established, but

more recent. In February 1996, heavy rain and snowmelt caused 700 landslides in metro Portland, with major damage to more than a hundred homes. Building on landslides should be as unthinkable as building unreinforced masonry. I hope you agree, and vote to stop this ill-considered and dangerous development.

Under this cover I write as volunteer on behalf of the Markham Neighborhood Association to report that a quorum of the association's membership voted at its January meeting to oppose to the approval of the above referenced land use application. This letter is of necessity written and submitted prior to the adoption of specific minutes by the association so this comment relies on memory.

To my recollection among the reasons given by representatives of South Burlingame in requesting Markham state its opposition to this application the one that seemed have resonance with Markham residents was that the proposal before the council would remove a large number of trees from the area to be developed. Based on my experience living in or near SW Portland for more than 40 years and recently acting as Markham watershed representative on SWNI Watershed Committee (and now committee chair) I believe this response is the product of not only an aesthetic concern but also a practical conviction that in the hilly areas of SW Portland downstream properties are inevitably impacted by such activity due to changes in the storm water regime occasioned by the tree removal. Unfortunately, I have to report to the Council that this seems to be true even in area the City's most up to date storm water management techniques have been applied to a property upon its development. The impact that this has had on neighboring owners of developed property is a continuing concern for residents of Markham as well as its surrounding neighborhoods. Because in the this case the most important area to be affected by this phenomena is an area which the City has the primary responsibility for, the confluence of Stephens Creek and the Willamette, it needs to be a matter of grave concern for the Council in making its decision on the appeal.



Additionally I would note that South Burlingame's and as we understand it, PBOT's, concern with requiring adequate transit improvements in connection with this application directly impacts the Markham neighborhood. Tri Met Route 43 as travels along SW Talyor's Ferry to the west of the subject site is the only bus that passes through the Markham neighborhood . Any improvement or enhancement to that service would be significantly welcomed by many Markham residents.

Dear Land Use Hearings Officer,

I have lived in SW Portland near the proposed Macadam Ridge Development since 2004, and I wish to write in support of the proposed development. There are at least two significant benefits to the neighborhood I would ask you to consider when making your evaluation. First, the additional homes could support restaurants and stores that have struggled to stay open in South Burlingame, and second it would help provide tax revenue to support the schools. The City is also becoming a really expensive place for young people to buy a home and any additional housing helps relieve a little bit of the pressure.

Myself and others want to live in a vibrant neighborhood that can support local restaurants, coffee shops, and a grocery store that are in walking of my home. The Macadam Ridge development could help add a vibrancy to the neighborhood and support shops, that the neighborhood has struggled to support.

I have been walking to the coffee shops and grocery store (Market of Choice) on the corner of SW Taylor's Ferry and Terwilliger for years. The shops are within walking distance of the proposed development, as well as my own home. I watched the Starbucks that I used to walk to recently close, and the building is now vacant. Before that a coffee shop named Cappuccino's went out of business and the building sat vacant for a long time. A marijuana shop went into another vacant store that I understand used to be a restaurant. Just last Friday La Costita on Terwilliger and Barbur Boulevard went out of business. I also watched my favorite neighborhood grocery store, Market of Choice, scale back the number of employees and what they offer in the bulk bin. There have been rumors that they may close the store. Having additional housing in neighbor would help support the neighborhood restaurants and stores that we can walk to and that give our neighborhood character.

Second, the new homes could raise tax revenue for badly needed improvements, without raising the already high property taxes. I already pay over \$8,000 a year in property taxes on my home and yet the kids can't drink out the drinking fountain at the elementary school my daughter attends (Capitol Hill) because of lead problems. Part of the school structure itself was constructed using unreinforced masonry and the building and its occupants are at considerable risk during a seismic event. I hear neighbors complain about the property taxes all the time. The new homes would add an additional tax base for badly needed improvements, without increasing our already burdensome property tax rates.

Finally, housing in Portland is getting expensive and out of reach for a lot of young families. I feel bad for the young people I work with who are trying to get into a home. Any modest increase in housing availability helps young people trying to get into the market. While the proposed Macadam Ridge Development is small, it is a little step in the right direction.

I hope you will realize that not everyone is South Burlingame is opposed to the development and consider some of the benefits it could bring to both the neighborhood and the City.
