

## ORDINANCE NO. 176181

\*Accept a \$90,436 grant from the U.S. Department of Justice, Office of Community Oriented Policing Services, Justice Based After-School program. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. U.S. Department of Justice, Office of Community Oriented Policing Services (COPS) has made second year funding available to the Portland Police Bureau for the Justice Based After-School (JBAS) program. JBAS is designed to foster educational, recreational and social opportunities made available to youth during after school hours. It is part of the COPS Office's commitment to advancing community policing through collaborative, preventative programs
2. The Portland Police Bureau has been awarded a \$90,436 grant to support Police Activities League (PAL) after school activities. Portland's program provides safe havens during the peak hours for youth crime and victimization and allow participating youth to interact with police officers who act as positive role models and mentors. The grant application has approved by the City council on 8/1/01 by Ordinance No. 175832.
3. The grant period is from 9/30/01 to 12/31/02.
4. This grant does not require a cash match and only direct program expenses are allowable costs.

Now, therefore, the Council directs:

- a. The Mayor is authorized to sign the cooperative agreement form the U.S. Department of Justice, Office of Community Oriented Policing Services, Justice Based After-School Initiatives Program.
- b. An increase in appropriation for FY 01-02 and transfer of funds for the grant is authorized as follows:
